

2. GSTN number and HSN code must be mentioned in offer letter. Also mention Basic Rate, GST (with Bifurcation i.e. SGST and CGST) clearly in your offer.
3. 2% GST TDS on payment of bills Rs.2.50 lacs & above for basic value will be applicable as per MGST Act under sec-51 of Goods Services Tax Act- 2017.
4. Please mention the name of Manufacturer & Country of origin, delivery period and conformity of material as per specification.
5. Delivery- Free unloading of goods at HAL Sites/Stores (Part/Full) Pimpri, Pune - 18.

15. **LATE DELIVERY CLAUSE** : In case the delivery of the goods are delayed beyond the stipulated delivery period as indicated in the P.O., Penalty @ ½% per week OR part thereof subject to a maximum of 5% max on the value of the material undelivered within the stipulated delivery period. In case vendor fails to supply as per specifications, penalty as specified above, shall be applicable till the order is executed.
16. **PAYMENT TERMS**: 90 days Open Credit from date of receipt of material at HAL Stores.
17. **RISK PURCHASE** : If the party fails to supply the material (whole or part) of the quantity against the Purchase Order, the material will be procured at risk and cost from other sources keeping the same terms and conditions.
18. **ARBITRATION** : In the event of dispute/difference between two parties (a) Dispute shall be resolved by mutual consultation. (b) Unresolved dispute shall be referred to Managing Director, HAL or his authorized representative who will be the sole arbitrator & his decisions will be binding on parties of the dispute.
19. All disputes arising out of this contract will be subject to Jurisdiction of Pune Court only.
